Tender form is surgical disposable obtainable on cash payment (non-refundable) from the Accounts Branch of JIMS, Jacobabad on submission of written request on the company/firm letterhead. No any bid may be modified/altered after the deadline of submission of bids.
- 2. Any offer & condition received terms of the tender not per as of this institute or framed enquiry/bidding document < under Sindh Public Procurement Regularity Authority (SPPRA) is liable to be ignored.

- 4. In case the contractor fails to execute the contract strictly in accordance with the terms & conditions laid down in the contract, the security deposited shall be forfeited.
- 5. Duly attested photo copy of valid C.N.I.C of Executive Authorized Representative must be attached with the tender along with copies of National Tax Number (NTN), General Sales Tax registration certificate and valid retail Drugs Sales License and also verified from current/ on seat District Health Officer, Jacobabad.
- 6. The sealed bids (separate technical financial bids further sealed in one

envelope) will be dropped in the tender Box placed in the Committee Room of this institute on the scheduled date & time or before.

- 7. The Procuring Agency shall disqualify a bidder if it founds, at any time, that the information submitted by him concerning his qualification was false and materially inaccurate or incomplete.
- 8. If procuring Agency found that quoted rates are higher than market rates then the complete bid document of bidder rejected.
- 9. The bidder will also enclose a certificate from Market Committee/Chairman Municipal Committee for his shop address/location.

B-TERMS & CONDITIONS

- The vender must have valid Wholesale License, financially sound, well reputed and have shop with comprehensive storage facilities. The shop must be situated within five (05) Km radius of the institute. The facility of supplies must be available round the clock. (In case of non-availability of reasonable wholesaler within 05 km, the radius may extend up-to District
- 2. In case, the contracting firm offers less discount in comparison to discount offered to other institution/Market Price/hospitals situated in Sindh, the Difference will be automatically deducted and adjusted in the bill, however, if any excess amount is paid, the same will also be deducted from the pending bills or security of the side firms.
- 3. The offered discount shall be from prices fixed by the the maximum retail concerned regulatory authority, the manufacturers (where concerned or to do so or sole importers for medicines and regulatory authority has permitted from market price for disposables.
- 4. The Tendered bound & conditions shall be all terms of the to accept / SPPRA Government and further condition introduced by any during the to the terms, conditions, Government period of contract in addition Rules & regulations of SPPRA.
- 5. Any erasing / cutting, etc. Appearing on the offer, must be properly signed by the person signing the tender.
- 6. The bidders are required to give their best and most competitive discount for the items.
- 7 The contractor will supply the medicine as per Drugs Act, 1976 and rules framed there under.
- 8. The contractor will provide an authentic price list of medicines if and when required for verification of bill.
- 9. The vendor / contractor will provide warranty certificate regarding quality of all drugs medicines, surgical disposable items, etc sold to this hospital Moreover, the

contractor will bound to provide the invoice of this source of purchase if and when required along with the warranty that these do not contravene any provision of section 23 of drugs Act, 1976 and the rules framed there under.

- 10. The be bound to supply the required brand of all drugs contractor will medicines recommended by this hospital. In case the contractor provides brands of own choice of higher rates than that of the demanded brand, the extra amount will be adjusted to the value of recommended brands accordingly.
- 11. All the bidders are required to provide complete documents in compact file for their assessment of qualification as prescribed under the rules. Only the firms which will be declared qualified by Procurement Committee will be entertained in the further contract proceeding.
- 12. The contractor will submit the bills on weekly basis for payment.
- 13. Deduction of income tax will be made as per prescribed rules
- 14. In case the contractor fails to supply the ordered items purchase will be made at firm's risk and cost from the open market.
- 15. The Director JIMS reserves the right to accept or reject any / all tender(s) without assigning any reason.
- 16. The Shelf life at the time of inspection shall be minimum 95% for domestic and minimum 90% for imported drugs.
- 17. Bidder will ensure that provided medicine shelf life not less than 02 years.
- 18. While tendering bidder quotation, the present trend / inflation I the rate of Drugs/Medicines, supplies etc in the market should be kept in mind. No request for increase in price due to market fluctuation in the cost of goods and services shall be entertained for the year 2018-19.
- 19. This institute will issue supply orders of individual medicine or stock purpose for 03 months medicine when and as required for the year 2018-19.
- 20. If successful bidder fails/delayed to provide medicine the contract will be terminate by Director JIMS and Performance Security shall be forfeited.
- 21. Medicines of Chinese, Indian and Hungary origin should be avoided except for the products having international recognitions or where there is no other option available like Benzyl Penicillin, Streptomycin, ATS, Anti Snake venom & other life saving drugs i.e. Adrenalin, Atropine etc.
- 22. The Procuring Agency or its representative shall inspect and shall send sample from any provided medicine with batch of to testing laboratory to confirm their conformity to the Contract specifications and the cost shall be borne by the supplier/bidder.
- 23. Bidder will ensure and provide certificate that if price up/down or variation in market that he will provide the Drugs/Medicine on the same rates fixed on this tender for the complete year 2018-19 and supply order issued by this institute when and as required for the year 2018-19.

- 3. The envelopes shall be sealed & marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion; Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened; The envelope "FINANCIAL PROPOSAL" shall be retained in the custody of Procuring Agency without being opened.
- Proposal, 4. The Procuring Agency shall evaluate the Technical without reference to the price and reject any proposal which do not conform to the specified requirements; During the technical evaluation, no amendments technical proposal shall be permitted; The Financial Proposals of bids shall be opened publicly at a time, date and venue to be announced and communicated to the bidders in advance.
- 5. After the evaluation and approval of the technical proposal, the Procuring Agency shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids only.
- 6. The bids found financial proposal of technically non-responsive or noncompliant shall be returned unopened to the respective bidders.
- 7. The bidder will provide maximum discount rate including all taxes on retail price of all medicines /disposable items as list mentioned below shall be accepted for the complete year of 2018-19.
