TERMS & CONDITIONS

- 1. The Bid process shall be governed by the SPPRA Rules 2010 (amended from time to time).
- 2. Joint venture (JV) companies shall not be allowed for this tender.
- Bid/Tender document can be downloaded online from website of SPPRA or JIMS; but tender fee receipt must be purchased before 10:00 AM. Without the receipt the bid will not be accepted.
- 4. Open Competitive Bidding SPPRA Rule No. 46 (2) 2010 amended from time to time, <u>Single</u> Stage Two Envelope Procedure:
 - a. Bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal;
 - b. Envelopes shall be marked as —FINANCIAL PROPOSAL and TECHNICAL PROPOSAL in bold and legible letters to avoid confusion;
 - c. Initially, only the envelope marked —TECHNICAL PROPOSAL shall be opened;
 - d. Envelope marked as —FINANCIAL PROPOSAL shall be retained in the custody of the procuring agency without being opened;
 - e. Procuring agency shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform to the specified requirements;
 - f. No amendments in the technical proposal shall be permitted during the technical evaluation;
 - g. Financial proposals of technically qualified bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance;
 - h. Financial proposal of bids found technically non-responsive shall be returned unopened to the respective bidders; and
 - i. Bid found to be the lowest evaluated or best evaluated bid shall be accepted
- 5. The Contract shall be valid initially for a period of one year i.e. 2020 21 and thereafter it may be extended for a further period of further 01 year on the same quoted rates and upon satisfactory performance basis as may be necessary on mutual agreement. The Director JIMS Jacobabad reserves the right to terminate the Contract at any time.
- 6. A separate contract agreement shall be done on stamp paper between JIMS Jacobabad and the successful bidder.
- 7. Withholding taxes and other taxes will be deducted as per government rules framed time to time.
- 8. The original Bank draft / Pay Order of 3% earnest money/security deposit should be attached with the Financial Offer/Proposal. Copy of same should also be attached with technical proposal without mentioning (erased) the amount.
- 9. The Scrutiny of technical evaluation will be performed by the Technical Evaluation Committee.
- 10. Only one rate for each item as per bid specification is acceptable, no alternate rate(s) will be accepted.

- 11. Over-writing, cutting, erasing in the Bid Document should be avoided, if there is any over-writing, cutting, or erasing the correction should be duly signed and stamped by the authorized person.
- 12. All required items shall be quoted in PAK RUPEES.
- 13. The bidder/bidder will be responsible to deliver the supplies of Laboratory Reagents/Kits/Supplies, X-Ray Films etc. at their own cost including transportation, insurance, and any other cost etc. (if any).
- 14. Successful bidder shall provide performance security @5% of the total bid value along with 0.35% stamp duty on the Contract Agreement and/or on value of supply/work order(s) as the case may be.
- 15. The bidder shall bear all costs / expenses associated with the preparation and submission of the bid(s) and the purchaser/procuring agency shall be in no case responsible for those expenses.

16. Rejection of Bid

- a. Submitted in other than prescribed forms, annexure and documents not attached.
- b. Incomplete, partial, conditional, alternative or late submission.
- c. Earnest money is not submitted.
- d. Subjected to interlineations/cuttings/corrections/erasures/ overwriting.
- e. The bidder refuses to accept the corrected total bid price at his own.
- f. The bidder tries to influence the bid evaluation / contract award.
- g. The bidder engages in corrupt or fraudulent practices in competing for the contract award.
- h. The bidder fails to meet all the requirements of bid eligibility / qualification criteria
- i. The bidder has been blacklisted by any public or private sector organization
- j. The bidder has been served any legal notices, displeasure letters or any unsatisfactory performance letters by any public sector, Government, Semi Government or any autonomous body or serious failures to provide satisfactory services.
- 17. Any offer received not as per terms & conditions of the tender/bid document of this Institute or framed under Sindh Public Procurement Regularity Authority (SPPRA) Rules 2010 (amended from time to time) is liable to be ignored.
- 18. In case the bidder fails to execute the contract strictly in accordance with the terms & conditions laid down in the contract, the Performance security deposited shall be forfeited.
- 19. Duly attested photo copy of valid C.N.I.C of Executive Authorized Representative must be attached with the tender with copies along General National Tax Number (NTN), Sales Tax Registration Certificate and valid retail Drugs Sales License.
- 20. The sealed bids (separate technical and financial bids further sealed in one envelope) will be dropped in the tender Box placed in the Committee Room of this Institute on or before the scheduled date & time.

- 21. The Procuring Agency shall disqualify a bidder if it finds, at any time, that the information submitted by him concerning his qualification was false and materially inaccurate or incomplete.
- 22. If procuring agency find that quoted rates are higher than market rates then the complete bid document of bidder rejected.
- 23. The bidder will also enclose a certificate from Market Committee/Chairman Municipal Committee for his shop address/location.
- 24. The bidder will provide maximum discount rate including all taxes on retail price of all medicines /disposable items as list mentioned below shall be accepted for the complete year of 2020-21.
- 25. Price should be quoted on delivery to consignee's end i.e. Main Medicine Store of Jacobabad Institute of Medical Sciences (JIMS), Jacobabad inclusive of all taxes, stamps, duties, levies, fees. No separate payment shall be made.
- 26. The purchaser should also provide prescribed format in soft copy (CD/USB) attached in offer (Soft copy of quotation can be obtained from the Office of Director JIMS, Jacobabad.
- 27. The bidder with the lowest evaluated cost, but not necessarily the lowest submitted price, shall be awarded the contract.
- 28. The firm should have proper office and indicate their telephone Nos., Fax No., Email in their offer and name of the person who can be contacted in an emergency.
- 29. No Government Servant should be involved in company business directly or indirectly.
- 30. The Client (i.e. Director JIMS, Jacobabad) reserves the right to accept or reject any/all tender(s) at any time without assigning any reason thereof.
- 31. This Contract may be reviewed/renew after completing of 01 year for further (next) 01 year on the same quoted rates and bidder performance basis.
- 32. In case, the contracting firm offers less discount in comparison to discount offered to other institution/Market Price/hospitals situated in Sindh, the Difference will be automatically deducted and adjusted in the bill, however, if any excess amount is paid, the same will also be deducted from the pending bills or security of the side firms.
- 33. The offered discount shall be from the maximum retail prices fixed by the concerned regulatory authority, or the manufacturers (where concerned regulatory authority has permitted to do so or sole importers for medicines and from market price for disposables.
- 34. The Tendered shall be bound & conditions of the to accept all terms Government / SPPRA and any further condition introduced by in addition Government during the period of contract to the terms, conditions, Rules & regulations of SPPRA.
- 35. The bidders are required to give their best and most competitive discount for the items.
- 36. The bidders will provide authority letters of quoted items.
- 37. The bidder will supply the medicine as per Drugs Act, 1976 and rules framed there under.

- 38. The bidder will provide an authentic price list of medicines if and when required for verification of bill.
- 39. The bidder will be bound to supply the required brand of all Procurement of Laboratory Reagents/Kits/Supplies, X-Ray Films Etc. recommended by this hospital. In case the bidder provides brands of his own choice of higher rates than that of the demanded brand, the extra amount will be adjusted to the value of recommended brands accordingly.
- 40. All the bidders are required to provide complete documents in compact file for their assessment of qualification as prescribed under the rules. Only the firms which will be declared qualified by Procurement Committee will be entertained in the further contract proceeding.
- 41. Sterility Certificate in case of Surgical Disposable items, Suturing material and Disposable Syringes should be provided by the bidder with Technical Bid. Without sterility certificate offer will be ignored.
- 42. Registration from the concerned authority has to be provided for supply of Disposable Syringes and other items. Without registration no bid for disposable syringe will be considered.
- 43. The authority (**Director JIMS, Jacobabad**) reserves the right to verify authentication of the certificates produced from the Manufacturer / concerned authorities i.e. importer / embassy / country of origin.
- 44. Samples/Brochures of products offered must be submitted with the tender. Without samples the offer will be ignored.
- 45. The bidder will submit the bills on weekly basis for payment.
- 46. Deduction of income tax will be made as per prescribed rules
- 47. It is mandatory that drugs/medicines/lab items etc quoted are registered with the Federal Ministry of Health
- 48. The supplies should be in commercial pack as per drug act 1976 and delivered at the designated place of JIMS by the authorized representative of the firm at the risk and cost of the supplier. Any breakage or shortage of stock will be recovered from the supplier.
- 49. Any liability arising on this institute or any other taxes pertaining to bidder/firm in the tenure of contract with this institute shall be deducted from the bills of the bidder and if the full amount is not recovered then the same shall be recovered from the Performance security of the bidder. There would be no liabilities of the workers of the bidder towards the Director JIMS.
- 50. No supply will be accepted having expiry date less than 80% of shelf life.
- 51. While tendering bidder quotation, the present trend / inflation I the rate of quoted items i.e. Laboratory items / supplies etc in the market should be kept in mind. No request for increase in price due to market fluctuation in the cost of goods and services shall be entertained for the year 2020-21.
- 52. This institute will issue supply orders of individual medicine or stock purpose for 03 months medicine when and as required for the year 2020-21 / part supply/part payment is permissible.
- 53. Medicines of Chinese, Indian and Hungary origin should be avoided except for the products having international recognitions or where there is no other option available like Benzyl

- Penicillin, Streptomycin, ATS, Anti Snake venom, Anti Rabies vaccines & other life saving drugs i.e. Adrenalin, Atropine etc.
- 54. Only manufacturer/importer or their authorized distributor can be participating in the tender process. If any Lab items/Surgical/Disposables etc. short in market the bidder must submit an application for temporary providing the alternate Lab items/Surgical/Disposables on the same/market based price.
- 55. Stores are required as early as possible, the bidder may, however give their short guaranteed delivery period by which the supply will be completed positively.
- 56. No Manufacturer / importer shall authorize their distributor / agent / any firm or person to quote the same item, which the manufacturer / importer is quoting itself in tender. Failing those offers of both, the manufacturer / importer as well as other bidder shall be ignored
- 57. The supply should be executed in minimum number of batches.
- 58. Pack size, Manufacturer name and country of origin should be mentioned in the offer.
- 59. The successful bidder bound to supply all the goods as per contract agreement within stipulated time. In case bidder deny/refuse to supply of same goods, the action under relevant SPPRA Rules, 2010 (amended time to time) and provisions shall be taken against the bidder.
- 60. The delivery of the required item(s)/good(s) and/or related service(s), if any shall be made by the bidder within stipulated date and time and/or after issuance of the supply order(s), but not more than 21 days of the supply order date; as the case may be.
- 61. If the bidder/supplier fails to deliver the required item(s)/good(s) and/or related service(s), if any within stipulated time as specified above, the Procuring Agency/Purchaser shall, without prejudice to its other remedies under the contract deduct from the Contract Price, as liquidated damages, a sum equivalent to 0.07 percent of the Contract Price for each day of delay until actual delivery and/or performance, up to a maximum deduction of 10% of the Contract Price and/or value of supply order(s). Once the maximum is reached, the purchaser may consider termination of the contract
- 62. The Director, Jacobabad Institute of Medical Sciences (JIMS), Jacobabad reserves the right to impose the following penalties for any breach of the contract by bidders.
 - a. Forfeiture f the Performance Security
 - b. Forfeiture of remaining payment
 - c. Black listing of the firm
